1. M. Tech (1st year) admission at NIT Delhi is based on CCMT 2021 centralized counseling process only. There will be **no other means/ mode of admission at NIT Delhi**.

2. **Online Admission** (as per the CCMT 2021 updated schedule) **Procedure/ Schedule** for M. Tech first year students will be carried out for the allotted candidates (CCMT 2021 provided list based on counseling) only.
