



# Memorandum of Understanding Concerning

#### **Academic and Research Collaboration**

#### Between

## National Institute of Technology Delhi

(Through its Director)

#### and

## **Galgotias University**

Sub-Sector 17, Gautam Budh Nagar, Greater Noida, U.P.

(Through its Vice-Chancellor)

National institute of Technology Delhi (herein after referred to as NIT Delhi) and Galgotias University recognize their strengths in research and academics in one or more disciplines of science, engineering, management and social sciences and their mutual interest in engaging themselves in academic and research cooperation.

Therefore, **NIT Delhi** and **Galgotias University** agree to establish a programme for academic cooperation in areas of mutual interest, and in accordance with terms and conditions set forth in this memorandum (MOU).

Through this MOU, both Parties affirm the value of collaboration and agree to promote the following activities:

- a) Cooperate in the exchange of information relating to the activities in research fields of mutual interests:
- b) Promote appropriate joint research projects joint consultancy, with particular emphasis on national and internationally funded projects;
- c) Joint supervision of postgraduate and Ph.D. students;
- d) Sharing of infrastructure facilities (during free slots) for faculties and students of both Institutes;
- e) Promote expert lectures by faculty members for B.Tech/M.Tech/Ph.D students of both Institutes;
- f) Conduct joint conferences/short-term courses/workshops/ seminar on topics of mutual interest, as mutually agreed in writing between the parties prior to commencement of the activity;

The aim of the MOU shall be to enable realistic co-operations in the respective contributions and benefits of the collaboration, and there shall be periodic review by both Institutes.

This MOU places no financial obligations or supplementary funding commitments on either side. The above activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each Institution.

**NIT Delhi** and **Galgotias University** agree to respect each other's right to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MOU will be worked out on a case-to-case basis and will be consistent with laid down IPR policies of the two institutions.

The day-to-day implementation of this MOU will be coordinated by **Dr. Suman Mann**, **Professor**, and **Dr. K.K. Aggarwal**, **Professor Galgotias University and Prof Manoj Kumar**, **Dept of ECE of NIT Delhi**. The coordinators, thus appointed, will periodically review and identify ways to strengthen cooperation between the two institutions.

This MOU will take effect from the date it is signed by the representatives of the two institutions. It will remain valid for 02 years from that date and may be continued thereafter also after suitable review and mutual agreement. Either institution may terminate the MOU by giving written notice to the other institution six months in advance. Once the MOU is terminated, neither **NIT Delhi** nor **Galgotias University** will be responsible for any losses, financial or otherwise, which the other institution may suffer. However, **NIT Delhi** and **Galgotias University** will ensure that all activities that are in progress are allowed to be completed successfully.
