The 9<sup>th</sup> meeting of the Board of Governors (BOG) of NIT Delhi was held on 25<sup>th</sup> March, 2014 (Tuesday) at 12:30 PM, under the Chairmanship of Shri R. Santhanam, Chairman, Board of Governors, NIT, Delhi. The following were present in the meeting:

Ms. Neelam Dhawan CEO HP India and Sh. N Krishnan, CTO and Member BOG, NIT Delhi could not attend the meeting due to their prior engagements.

The Chairman welcomed all the members of the Board of Governors.

Before discussing the agenda points, the Director presented his progress report for the last 4 months and 9 days of NIT Delhi after holding its 8<sup>th</sup> previous BOG. It was informed that after taking possession the leasing space from IAMR campus and after necessary alterations and furnishing the academic and hostel areas, the institute has shifted from IIT, Dwarka to IAMR Campus, Narela on 18<sup>th</sup> February, 2014. The members were also apprised about the development of various academic and other infrastructures that took place in short span of time like: Library and its Automation, Computer Centre, High End Servers, Mess and Canteen Facility, hostel for students and necessary Lab Equipment etc.

The members were further informed about the visit of team comprising of Director, BWC member and a faculty of NIT Delhi to Singapore and their meeting (held on 20<sup>th</sup> March, 2014) with Professor Lui Pao Chuen, Advisor to National Research Foundation at Prime Minister's office at Singapore, to know their thorough process and ideas to develop a world class Infrastructure. Thereafter, inputs required were considered for preparing of Master Plan, Architects and Consultants behind building the structure, Construction and Operation Cost along with the time required completing the building from the inception of idea to possession of land. Further, inputs regarding Maintenance Schedule Plan for the building, State of art facilities available in infrastructure, facilities and services retained in-house and outsourced were also undertaken into consideration. Also inputs regarding Expansion plans for building, keeping in view present intake and courses offered and future courses to be offered were taken into account. After discussion, the board members stressed that similar concept and infrastructure may be adopted while developing the Master Plan of NIT Delhi and the process of phase-wise development of infrastructure for NIT Delhi may be initiated

including academic and residential facilities along with the provision of collaborative research and innovation centres.

The members of the BOG noted the action taken on the decisions of the last meeting held on 16<sup>th</sup> November, 2013. However, against Item No. 8.17, the Board suggested that the present logo with its lengthy content is not so appealing and it needs to be redesigned with crisp and precise content in line with other traditional logos of Nationalised Indian Technical Institutes.

## ITEM NO. 9.3

# TO CONSIDER ADOPTION OF RECRUITMENT RULES (RRs) FOR NON-TEACHING POSTS IN THE NATIONAL INSTITUTE OF TECHNOLOGY (NITs)

The Director informed the Members that the MHRD, New Delhi has prepared and finalized the Recruitment Rules for the Non-Teaching staff for all the NITs in the country and a copy of the same was placed across BOG members for their information.

The members after going through the Rules finally adopted the same.

## ITEM NO. 9.4

## VISION, MISSION AND QUALITY POLICY OF NIT Delhi

The Director explained in detail about the Vision, Mission and Quality Policy of the NIT Delhi. There was a detailed discussion on this matter and finally it was decided that the Institute may go ahead with the present statements in order to reflect the same on NIT Delhi official documents. However, it can be further improved after taking the valuable suggestions from the Board Members and may place it in the next meeting of the Board of Governors.

## ITEM NO. 9.5

# TO CONSIDER ADOPTION OF MOBILITY OF FACULTY AND NON-FACULTY PERSONNEL TO THE NEWLY ESTABLISHED CENTRAL EDUCATION INSTITUTES (CEIs) & SCIENTIFIC INSTITUTIONS AND ADMISSIBILITY OF PENSIONARY BENEFITS

The Director conveyed the matter written in the Letter No.15-1/2012/IFD dated 18<sup>th</sup> February, 2014 and Letter No. F.No.8-9/2008-T.S.1 dated 28<sup>th</sup> December, 2011 of Ministry of Human Resource Development, Dept. of Higher Education, regarding the mobility of faculty and non-faculty personnel to the newly established Central Education Institutes (CEIs) & Scientific Institutions and administratively personal benefits to the faculty/staff on their mobility from one autonomous organization to another on deputation.

The members discussed the above communication of the MHRD, New Delhi and adopted the same for implementation.

## ITEM NO. 9.6

#### TO CONSIDER THE FACULTY PERFORMANCE APPRAISAL PROFORMA

The Director informed the members that a proforma for faculty performance appraisal has been designed. The members have gone through the proforma and expressed their desire to revise it in the light of target dates, output process learning & development, concept of balance score card etc. Further, Director was authorized to revise the same with the help of Board Members and may place it in the next meeting of the Board of Governors.

## ITEM NO. 9.7

#### TO CONSIDER STUDENT FEEDBACK PROFORMA

The Director informed the members that he has designed a proforma to get the feedback from the students about the performance of the teachers, which is essential and such practice is being done in almost all the Professional Institutes in India. The members have gone through the proforma and emphasized over its revision. Further, the Director was authorized to revise the same with the help of board members and may place it in the next meeting of the Board of Governors.

#### ITEM NO. 9.8

# TO CONSIDER THE FORMAT OF DEGREE (B.Tech, M.Tech. & PhD) AND TRANSCRIPT FOR NIT DELHI

The Director stated that the students admitted to first semester in the year 2010 for B.Tech Programmes at NIT Warangal on behalf of NIT Delhi are going to complete their degree by July, 2014 and DMCs/ Grade Sheet/ Degree has to be issued to them in time. Therefore, the proformas of such DMCs/ Grade Sheet/ Degree were presented to the members.

The members discussed in detail and emphasized to redesign the Degree capturing less number of words, with printing on both sides of the sheet in Hindi and English. The members authorised the Director to put up the revised Logo and the proforma of Degree & DMC/Grade Sheet and its implementation as early as possible. Further, in order to maintain

uniformity and to avoid misperception of two types of grade sheets issued to the students on the letter head of NIT Warangal and NIT Delhi, it was decided that the old grade sheets issued by NIT Warangal as mentor Institute should be retained by NIT Delhi and fresh Grade Sheet along with a transcript may be issued to the students on the letter head of NIT Delhi.

# SIGNING OF MEMORANDUM OF UNDERSTANDING WITH THE UNIVERSITY OF JOHANNESBURG, SOUTH AFRICA

The Director informed the members that he has received a proposal from the University of Johnsberg South Africa for academic collaboration with the NIT Delhi.

The above proposal was discussed by the Committee in detail and expressed that the Director should discuss the same with the concerned party regarding the plan to execute the terms stipulated in the MOU with clear output and outcome indicators. The members also emphasized that after signing of MOU, the outcome is essential therefore every MOU should be owned by the faculty of NIT Delhi who can act as co-ordinator of MOU.
