- 3. The candidate should remit the fee (Rs. 1,06,500/- only) as attached as Annexure I for the Semester I of Self-Financed MTech (Full Time) programs to the Institute account through Online mode/NEFT/RTGS only. No fee shall be accepted through any other means such as DD/Cheque/Cash etc.
- 4. After fee payment as per point no. 3, the candidate must submit the proof of payment through the google form link by July 28, 2024, 11:55 PM, https://forms.gle/A3BUrff5Jh1fgtZX7, failing which the allotted seat will be considered as cancelled automatically.
- 5. Fee once paid is non refundable, only caution money shall be refunded in case of withdrawal.
- 6. Due date for fee submission is July 28, 2024, 11:55 PM, failing which offer of admission shall stand cancelled and shall be allotted to the candidate in waiting list/subsequent rounds.
- 7. The student admitted to the Self-Financed MTech (Full Time) Programs, shall not be granted any scholarship/stipend/Teaching Assistantship by the Institute, even though he/she qualifies GATE in future or has qualified GATE.
- 8. The SFS MTech (Full Time) programs are same to the regularly run MTech programs in which admissions are made through CCMT except the fee structure and the GATE stipend. There is no distinction regarding the course delivery, placement & internship opportunity and other facilities extended to the students of the Institute.
- 9. The Classes for SFS MTech (Full Time) programs shall commence from August, 2024 along with the candidates admitted through CCMT 2024 (the date will be communicated soon).
- 10. Allotment of hostel is subject to availability. Allotment will be made after physical reporting of the eligible candidates to the institute.
