

The Registrar further briefed that the Institute has followed a transparent procedure for recruitment. The Institute has uploaded shortlisting criteria and the list of shortlisted/not shortlisted candidates with reasons of ineligibilities on the Institute website inviting representations from the candidates. The representations received were considered by the ACoFAR Committee and the final list of eligible/shortlisted candidates was uploaded on the Institute Website. It was also briefed that none of the Internal Candidates was eligible for the post as per the laid down eligibility criteria.

The Registrar further briefed that a complaint was received from Mr. Manoj K Karma vide email dated 26th April, 2023 on the candidature of Dr. Ujjwal Kumar Kalla for the post of Professor. The said complaint was placed before the ACoFAR Committee. The Selection Committee meeting for the post of Professor in Electrical Engineering Department was scheduled on 28th April, 2023. As per the recommendations of the ACoFAR committee, the Selection Committee meeting was postponed and the contents of the complaint were sent to Engineering College, Bikaner for verification of experience details. The Director briefed that the Institute has collected the information from the concerned authorities for the points raised by the complainant. The information received from the Engineering College, Bikaner was placed before the ACoFAR Committee. The ACoFAR Committee after due deliberation found that that there is no substance in the complaint and recommended for holding the Selection Committee for recruitment to the post of Professor. Accordingly, the Institute has informed the Ministry of Education vide email on 16th May, 2023 and a copy of the same email was marked to all concerned in the Ministry of Education that the documents have been verified and the Selection Committee meeting has been scheduled on 16th May, 2023.




