The Memorandum of Understanding (MoU) is hereby entered into on the 4th June, 2014.

BY and BETWEEN

National Institute of Technology, Delhi (hereinafter referred to as Partners) represented by the

Director, having its office at National Institute of Technology, Delhi.

AND

Lahti University of Applied Sciences, Finland (hereinafter refereed as Partners) represented by

the Project Executive having its office Niemenkatu 73, P.O. Box 213, FI-15101 Lahti, Finland.

From now onwards called as partners to promote academic and research co-

operation between the two institutes.

1. Objectives:

I. The partners will together discuss and develop training programmes for students, staff

and other potential clients within the areas of collaboration including credit transfer.

II. The partners will undertake joint research work in the areas of mutual interest.

III. The faculty members of the partners will formulate research projects and HRD plans for

joint work with due approval of both the participating institutions.

IV. Joint sponsored and consultancy projects may be undertaken with both long term/ mid-

term and short term goals, keeping in view the interests and philosophies of the

respective institutions.

2. Exchange/ deputation of Staff

The partners jointly agree.

- I. To exchange staff through deputation on full time/part-time basis for a limited period maximum up to one year at a time for the purpose of implementation of joint tasks within the areas of cooperation. These exchanges are jointly agreed on a case by case
- II. That the faculty/staff will be encouraged to deliver lectures/invited talks at the other Institution.
- III. To hold/conduct, whenever feasible, joint workshops, conferences, training courses within the areas of co-operation.

3. Miscellaneous:

- I. Sharing of facilities, project/ training work of students, areas of co-operation and publications and patents are agreed in further discussions on a case by case basis.
- In case of joint research and consultancy projects taken up by the partners, no party will II. disclose any part of investigation to media in any form without mutual consent other matters regarding the collaboration can be used freely for marketing purposes.

4. Validity & Period:

- I. This MoU shall be valid initially for a period of three years from the date of signing.
- II. At the end of validity of the MoU, a fresh MoU with similar/modified terms may be considered for signing.

In witness whereof the undersigned, duly authorized, have signed this Memorandum of Understanding at Delhi on 4th June, 2014. It has been executed in two originals; one has been retained by Lahti University of Applied Sciences and the other by National Institute of Technology, Delhi.
