Subject: Simplified Online Course Registration Procedure at IMS Platform of NIT Delhi

All faculty, non-faculty and students of NIT Delhi are hereby informed regarding, modified and simplified online student's course registration process at Institute's IMS platform, from upcoming Autumn Semester 2018-2019 onwards.

- Application for pre-registration of elective and open elective courses will be initiated
  by the office of Academics and ERP, depending upon the received choices from various
  academic departments and with a prior notification well in advance before the
  commencement of any semester.
- Core courses are mandatory and are fixed according to the curriculum of various programmes under various departments. The same will be fixed at IMS, until there is a major change in curriculum.
- 3. Now onwards, online course registration will be sole responsibility of the student only by proper selection of core/ elective/ open elective etc. courses, while registering at IMS platform and there will not be any responsibility of the Academic departments/ Academic section/ ERP section etc. regarding any discrepancy on behalf of students for online course registration.
- 4. There will be no longer any step for online course verification by the concerned Academic departments before the online or offline fee payment for registration by the students.
- 5. ERP section may be responsible for any technical discrepancy only.

6. Students are advised to accomplish very carefully the online course registration now onwards. Once registration is locked, there will not be any provision to re-invoke the same.

In accordance to above, the updated user manual regarding online course registration at IMS platform will be circulated in due course of time before the online course registration for Autumn Semester 2018 - 2019 according to Academic Calendar.
