As per report of the Committee for examining the revised cost estimates of NIT Delhi attached with the approval letter no. 33-1/2012.TSIII dated 04.03.2020 (**Annexure- III, Page No. 11-20**) a sum of Rs. 90.10 Crores has been allocated as external development works for Phase 1A & 1B construction works. Out of which a sum of Rs. 10.06 Cr. has already been spent on Phase 1A works and a

Thus, a sum of Rs. 66.04 Cr. is lying in the external development works and the same has not been taken into consideration by TCIL. It was therefore, proposed that the balance external development works to the tune of Rs. 50.18 Cr. may be awarded to TCIL so that the same can be completed with the completion of Phase 1B works. The proposal has been recommended by the B&WC in its 20th meeting held on 16/03/2023. TCIL has submitted a proposal which is placed as **Annexure IV, Page No. 21-101**.
