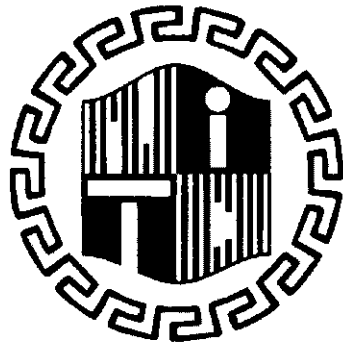

At the outset, Chairman welcomed all the members present in the meeting and taken up the following Agenda Items:




ITEM NO. Senate/01/2015/01**TO CONSIDER AND APPROVE RULES AND REGULATIONS FOR B.TECH PROGRAMME FOR THE BATCH 2015 ONWARDS.**

The recommendations of the IBOS deliberated in detail in the Senate meeting and the proposed Rules and Regulations for B.Tech Programme is approved to be implemented from the Academic Year 2015-16 with the following modifications:

- i) Minimum attendance of a student should be 75%.
- ii) Weightage for attendance should be as under:
 - a) 75% above = Marks 3
 - b) 80% and above = Marks 4
 - c) 90% and above = Marks 5
- iii) Credits allotted to Basic Sciences should be ≥ 20 Credits instead of ≥ 24 Credits.
- iv) Departmental Project should be a mandatory course instead of being optional.
- v) Students should be encouraged to do their project in the final year in collaboration with industries.
- vi) In this regard, students will be encouraged to do summer internships in industries for a period for 6 to 8 weeks at least.
- vii) It was decided to introduce Grade 'E' (Exposure Grade) instead of 'F' Grade but they do not have to study the pre-requisite subjects, if already passed. But, this grading system may be finalized with Hon'ble Senate Member, Dr. Y. N. Singh as per IIT Kanpur pattern.
- viii) 'Z' grade should be removed from the Grading System.
- ix) For promotion, students should earn atleast 50% of one year maximum around 25 credits. 180 credits should be earned with grades $\geq D$ or atleast = D.
- x) The lecture (L), Tutorial (T) and Practical (P) Credit distributions should be elaborated in the regulations as well as in the Scheme.
- xi) The committee considered that under malpractices (a) "Possession of answer book of another candidate. Giving answer book to another candidate" is as equal as (b) "Misbehaviour in the Examination hall (unruly conduct, threatening the invigilator, or any other examination officials). Therefore, the punishment for both (a) and (b).
- xii) Revised Assessment of theory courses approved as under:

Theory Course	Existing	Revised
Continuous Evaluation	20 marks	25 marks [5 marks for attendance]
Mid-semester Examinations	30 marks	25 marks
End-semester Examination	50 marks	50 marks

The Hon'ble Members of the Senate approved the above Rules and Regulations for B.Tech Programme for the Batch 2015 onwards and recommended to be placed before the Board of Governors for ratification.

ITEM NO. Senate/01/2015/02**TO CONSIDER AND APPROVE RULES AND REGULATIONS FOR M.TECH PROGRAMME FOR THE BATCH 2015 ONWARDS.**



The recommendations of the IBOS deliberated in detail in the Senate meeting and the proposed Rules and Regulations for M.Tech Programme is approved to be implemented from the Academic Year 2015-16 with the following modifications/additions:

- i) The modifications approved by the Hon'ble Members of the Senate for B.Tech. Programme will also be applicable for M.Tech Programme.
- ii) Independent Studies: On this point all the members of the Senate decided that Independent Study has to be there.
- iii) M.Tech. Scheme: It was decided that Course on Advanced mathematics should be taught to the M.Tech students and course from Applied Sciences has to be incorporated in the scheme as mandatory core course.
- iv) Inter-subject availability: It was decided that a B.Tech Student can take M.Tech courses as Electives.
- v) Grading System: Relative Grading should be introduced instead of Absolute Grading for M.Tech. 2016 batch onwards.
- vi) Feedback: Feedback from students on the course should be taken at the Middle of the Semester so that corrective measures can be taken.
- vii) The Member also approved that in the Department of Electronics and Communication Engineering may start M.Tech in VLSI subject from next Academic Year. However, the Institute will make necessary efforts first to appoint the required faculty before the commencement of next Academic Year.

The Hon'ble Members of the Senate approved the above Rules and Regulations for M.Tech Programme subject to above modifications for the Batch 2016 onwards and recommended to be placed before the Board of Governors for ratification.

ITEM NO. Senate/01/2015/03	TO CONSIDER AND APPROVE RULE AND REGULATIONS FOR Ph.D PROGRAMME EFFECTIVE FROM JANUARY 2015 ONWARDS.

The members considered the recommendations of the IBOS and approved the proposed rules and regulations for Ph.D Programme with following additions:

- i) External Guide: Selection from Thesis Evaluation should come through proper channel Supervisor-DPGC Convener-HOD-Dean R&C-Director to ensure proper quality of experts.
- ii) Selection of Supervisor/Co-supervisor: No concept of Supervisor & Co-supervisor if there are more than one Guide, for in house everybody will be named as supervisor otherwise the outside guide may be named as Co-supervisor.
- iii) Grading System and Credit Requirement: Grading should be Relative and passing full requirement should be now 7.5 instead of 6.5 for the 2016 batch onwards.
- iv) Subject Selection: Students can opt for as many courses for course work even after completing required credits and it must be mentioned in the Regulations.
- v) Credit: For Science students credit should be reduced to 14 from 17.




- vi) Online Courses: Online courses like NPTL will be introduced as the main credit courses to the students where the instructor will do only the evaluation but no classes will be taken by him.
- vii) Credit Transfer: Credit transfer for the mapping of courses in case of MOU with other institutions the term should be named as course waiver.

The Hon'ble Members of the Senate approved the Rules and Regulations for Ph.D Programme for the Batch 2016 onwards and recommended to be placed before the Board of Governors for ratification.

Whereas, Mr. Gajendra Singh Roll. No. 131200017 is found to impersonate Mr. Abhishek Ranjan of his class may also be debarred from continuing his studies and writing all examinations for two years.

The Hon'ble Members of the Senate approved the decision of the IBOS and advised to be strict on such indiscipline activity and recommended to be placed before the Board of Governors for ratification.
