The Senate members suggested that some new courses may be offered as Open Electives which may include MOOC's courses.

It was also suggested that the courses like Cloud Computing, Mobile Computing and Big Data Analytics etc. may be offered as Core courses. HOD (CSE) informed the Senate members that above courses are already being offered under "Elective Courses".

The Senate members suggested that some new courses may be offered as Open Electives which may include MOOC's courses.

The Senate members suggested that instead of offering the group wise elective courses for B. Tech students in new curriculum, elective courses may be offered under various bouquets assigned for various electives courses. This may be helpful for students to avoid any ambiguity to opt for any elective courses with specific pre-requisite courses and may provide more flexibility to them to choose elective courses of their own interest.

The Senate members suggested that instead of offering the Elective Courses in a specified 'Group' for the B.Tech students, the same may be offered under a 'Bouquet' so that there may be no restriction on the choice of subjects by the students which will provide them more flexibility to study varied courses of their interest area(s). It was suggested that the 'Group System' may





be followed in M.Tech programme for providing specialized group of subjects at an advanced level.

Also, the Senate members suggested that some new courses may be offered as Open Electives which may include MOOC's courses.

With these observations, the Senate considered and approved, in principle, the above agenda item for B.Tech programme (3rd & 4th year) for Department of Electronics and Communication Engineering. The Senate members will study it further and will provide a detailed feedback on the same.

Such Courses on administration should be offered at UG, PG and PhD levels. For the same, MOOCS option can be explored. The Senate members observed that there is a repetition (i.e. 03 times) of Course Title 'Research Methodology' offered with difference in the course contents of the Course under the same title. Thus, it is suggested that a single course may be offered under the Title 'Research Methodology' and the course content may be designed accordingly. Further, the Senate members suggested that in B. Tech 1st and 2nd Year, two elective courses on "History of India" and "History of Science and Technology" may be offered by the Department of Humanities and Management.
