- (a) The choice of elective/ open elective courses will be based on the pre-registration basis, which has to be completed well in advance before the semester registration.
- (b) There will be a provision for dropping/ switching of elective/ open elective courses within 2 weeks of commencement of semester only. After that no such above modification will be entertained.
- (c) There may be a minimum 20% of the total strength of the students in the class required to conduct any elective courses; however, it shall be the prerogative of office of Head of the Department's in taking the final decision.
- (d) There may be a minimum 20% of the total strength of the students(from other department) required to conduct any open elective courses; however, it shall be the prerogative of office of Head of the Department's in taking the final decision.
- (e) In case of switching of courses, the attendance shall be transferred in between the faculty members.
