# By and Between

SRM University Delhi NCR, Sonepat (SRMUH), a State Private University duly incorporated and established under the Haryana Private Universities Act, 2006 having its address at 39, Rajiv Gandhi Education City, Delhi-NCR, Sonepat – 131029, Haryana, acting through its Registrar, Prof. V. Samuel Raj, hereinafter referred to as "THE FIRST PARTY", which expression shall unless excluded by or repugnant to context shall include its successors-in-interest, group companies, parent company, affiliates, holding company, sister concerns, and permitted assigns of the FIRST PART.

#### **AND**

National Institute Of Technology Delhi (NIT Delhi), duly incorporated and established under the NIT ACT 2007 having its address at Plot No. FA7,Zone P1, GT Karnal Road, Delhi-110036, acting through its Registrar, Dr. Hitesh Sharma, hereinafter referred to as "THE SECOND PARTY", which expression shall unless excluded by or repugnant to context shall include its successors-in-interest, group companies, parent company, affiliates, holding company, sister concerns, and permitted assigns of the SECOND PART.

## 1. OBJECTIVES OF THE MOU

The objectives of this MoU are:

- a. The objectives of this co-operation is to foster collaboration and facilitate the advancement of knowledge on the basis of reciprocity, best effort, mutual benefit and frequent interactions.
- b. SRM University and NIT DELHI agree to explore the possibility of engaging in the following areas of collaboration:
  - Exchange of intellectual know-how and resources.
  - Partnership in innovation and entrepreneurship driven opportunities and resources.
  - Sharing of scientific-technical network and infrastructure resources.
  - Partnership of collaborative consultive and research projects.

### 2. PROPOSED MODES OF COLLABORATION

- i. SRM University and NIT Delhi propose to collaborate through the following:
  - a) Co-operation and promotion of research and education in areas of mutual interests,
  - b) Facilitation of joint research programmes/proposals,
  - c) Sharing of graduate programmes between the two institutions,
  - d) Exchange of academic personnel between SRM University and NIT Delhi,
  - e) Organization of joint conferences, seminars, FDPs, workshops
  - f) Laboratory visits for students and faculty members
  - g) Any other appropriate mode of interaction agreed upon between SRM University and NIT Delhi.
- ii. Research collaboration between the two institutions will be undertaken with individual written agreements when necessary.

### 3. CONFIDENTIALITY

- a) Individual faculty involved at SRM University and NIT Delhi agree to hold in confidence all information/data designated by the parties as being confidential which is obtained from either party or created during the performance of the MoU and will not disclose the same to any third party without written consent of the other party.
- b) The above confidential clause under this MoU excludes information/data possessed by either party before entering into this MoU or independently developed and/or information already available through public domain, or information which is required to be disclosed by any law or disclosure of such information is directed by a court, tribunal or any competent authority.

#### 4. TERM AND TERMINATION

a) This MoU shall be valid for five (5) years unless extended by mutual consent of both the Parties. A Party willing to extend the MoU shall give a written notice of its intention to extend, at least 60 days prior to the expiry of MoU, which may be accepted by the other Party within a period of 30 days from the receipt of such notice.

- b) Either party shall have the right to terminate this MoU with 60 days prior written notice to other party.
- c) The termination of the MoU shall not affect obligations as of the participant under any research agreement. Confidentiality clause obligation as referenced in clause 5 shall survive such termination.
