TERMS AND CONDITIONS

 The work shall be carried out as per latest CPWD specifications for Civil and Electrical works with upto date correction slips and as per the direction of Engineer-in-charge. The quantities given in the schedule of work for all the items are tentative. The work shall be carried as per actual requirement as approved by the Engineer-in-Charge.

Bidder's quoted Rates for executing the work shall remain firm till completion of the entire work & shall not attract any escalation under any circumstances whatsoever. The quantities mentioned in BOQ are tentative which may be increased or decreased as per the requirement of the Institute.

3. NIT Delhi shall not be held responsible for delay in submission of quotation.

- 4. Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, and in general shall themselves obtain all necessary information as to risks contingencies and other circumstances which influence or effect their bid. A Bidder shall be deemed to have full knowledge of the site, whether he inspects it or not and so no extra charges consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work. Submission of a bid by a bidder implies that he has read this notice and all other documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors bearing on the specification of the work.
- Work will be executed as per latest CPWD Works Manual & CPWD General Conditions of Contract for Maintenance Works.

Rates quoted by the bidders shall be inclusive of GST (Goods and Services Tax) and all applicable taxes. Taxes and all other statutory deductions like labour cess etc. will be deducted from the bill as per prevailing rules.

- Contractor will devise a system to keep a watch on quantum of work taken up vis-à-vis balance items required to
 complete defined scope of work and will give the alerts to Engineer-in-Charge before taking up extra items and
 deviations.
- 8. Payment will be released based on actual measurements. No advance payment will be made to the contractor

The contractor shall clean the site thoroughly of scaffolding materials, rubbish/malba, equipments left out of his work & dress the site to the complete satisfaction of the Engineer-in-Charge before the work is treated as completed.

10. The Contractor shall complete the work within the time frame as stipulated, failing which, NIT Delhi will recover Compensation for Delay of work @ 0.5% of the total amount of work as per Work Order per week of delay subject to maximum of 10% of the accepted value of the Work.

11. 2.5% of the bill amount will be retained by the Institute as security deposit, which will be released after completion of defect liability period of 12 months

- For substandard/Incomplete work penalty may be imposed and suitable recovery will be made from bill of the contractor.
- 13. The material should be used as per approved make of list. Material should be shown to the Engineer-in-charge before execution.
- 14. The agency is fully responsible for the safety of working personnel and must follow all government safety rules.
- 15. Any damage done by the contractor to any existing item/any part of the building during execution of work shall be made good at his own cost.

16. The right of acceptance or rejection of any or all the quotations is reserved without assigning any reason with the Competent Authority of NIT Delhi.

- 17. Financial loss/liability incurred due to negligence/default on the part of the contractor or his staff, non-compliance of the provisions of the NIQ and not executing the work as per the instructions, would constitute sufficient ground for annulment of the award and will be considered and liable to be blacklisted/debarred from participating in the future bids in the Institute for the period of two Year.
- 18. Use of correction fluid in quotation not to be allowed. Such quotation is liable to be rejected.

19. The quotation shall remain valid for 75 days from the date of opening.

20. Any dispute will be subject to the territorial jurisdiction of Rohini District Court Delhi only.
