Subject: Signing of MoU with Foreign Universities / Institutions – regarding.

Madam \ Sir,

The Ministry has been receiving a number of references from the NITs and & IIEST, Shibpur, on the above mentioned subject, for seeking administrative approval.

- The matter has been examined in light of the provisions under the National Institutes of Technology, Science Education and Research (NITSER) Act, 2007 and Statutes framed under the Act. It is seen that Section 13 of the Act, declares the Board of Governors of the Institute as the apex decision making body responsible for general superintendence, direction and control of the affairs of the Institute and shall exercise all the powers of the Institute.
- Similarly, Section 6 (1) (I) of the NITSER Act, empowers the Institute to: 3.

"co-operate with educational or other Institutions in any part of the world having objects wholly or partly similar to those of the Institute by exchange of teachers and scholars and generally in such manner as may be conducive to their common objects."

It has been further seen that the ICC Division of Ministry vide guidelines dated 17.12.2015 regarding signing of MoUs with foreign agencies, has specifically mentioned that:

'if there is a provision in the Act (under which the institution has been established) to enter into an agreement with the foreign institution, the institutions can enter into MoUs / Agreements with the approval of their respective Board of Governors provided there is no additional financial implication for the Government over and above the lump sum annual grant already provided to the institution and the MoU / Agreement conforms with the National Education Policy, Acts of Parliament and any other laws of the land in vogue'.

- 5. All NITs and IIEST, Shibpur are, therefore, requested to take necessary action in the matter, in the light of the explicit provisions already available under the NITSER Act, 2007, adhering to ICC guidelines as mentioned above. However, to disseminate knowledge through distance learning mode to various parts of the State or country or abroad in case of signing of agreement with any foreign agency, provisions under clause (xiii) of Statute 8 shall continue to be followed in letter and spirit. Similarly, signing MoUs with Chinese Institutions / Universities shall continue to be governed by the instructions contained in this Ministry's OM dated 20.09.2019 (copy also enclosed).
- 6. The information regarding signing of MoUs with foreign Institutions may be shared by NITs with Ministry from time to time, initially by way of correspondence to the Ministry and later through a portal to be developed for the purpose.
- 7. This issues with the approval of Secretary (HE).

Subject:

Entering into agreement with foreign agencies for cooperation in field of education – reg.

In supersession of all earlier issued instructions for entering into an agreement with foreign agencies for cooperation in field of education, the following course of action is to be adopted:

- a) In cases of MoUs/ Agreement at Institutional level, where there is a provision in the Act (under which the institution has been established) to enter into an agreement with the foreign institution, the Institutions can enter into MoUs/ Agreements with the approval of their respective Board of Governors provided there is no additional financial implication for the Government over and above the lump sum annual grant already provided to the institution and the MoU/ Agreement conforms with the National Education Policy, Acts of Parliament and any other laws of the land in vogue. The representative(s) of the Department in the Board of Governors may safeguard the interests of Government at the approval stage; and
- b) If there is no provision in the Act of the Institution for signing MoU/ Agreement with the foreign institutions, MoUs/ Agreements may be signed with the approval of the Ministry in consultation with the Ministry of External Affairs.
- c) In cases of MoUs/ Agreements between Government to Government, approval of the Cabinet may continue to be taken in terms of extant instructions and after completion of the laid down process.
- 2. All Bureau Heads in the Department of Higher Education and in the Department of School Education & Literacy are requested to circulate these instructions to all Subordinate/Attached bodies, Constitutional/Statutory Bodies, Autonomous Organizations/Institutions and authorities under their administrative control for strict adherence.
