#### **Pattern of Examination:**

For the post of Junior Translator (Hindi) Purely on Contractual and Temporary Basis, an OMR-based written examination of 100 marks will be conducted. The duration of the exam will be 1 hour and 30 minutes, consisting of 100 multiple-choice questions, each carrying one mark. There shall be no negative marking for any incorrectly attempted question.
