Minimum Experience in regular position and regular pay-scale as required for the advertised post as stipulated vide Schedule E of Gazette of India No.651, dated July 24, 2017, and First Statutes of the National Institutes of Technology (Amendment) Statutes, 2023 vide the Gazette of India Notification No. 484 dated 07th July 2023.
  - v. Post is advertised for the respective category.
  - vi. Hard copy of the application form with complete information along with requisite documents is received.
